

Oldest Furnace ® GIVEAWAY OFFICIAL RULES

1. **THE PROMOTION AND SPONSOR.** The Oldest Furnace Giveaway promotion (the "Promotion") is subject to these Official Rules and all applicable federal, state and local laws. The Promotion is sponsored by Burton HVAC, Plumbing, Electrical and more, LLC located at 5010 F St. Omaha, NE 68117. By participating in the Promotion, you agree to be fully unconditionally bound by these Official Rules and any decision Sponsor makes regarding this Promotion, which Sponsor shall make in its sole discretion, and you represent and warrant that you meet the eligibility requirements set forth herein. Sponsor's and other trademarks or logos used herein are trademarks of their respective trademark owners. Sponsor reserves the right to correct or change any and all typographical or mechanical errors in these Official Rules or in any other promotional statements issued in connection with the Promotion.
2. **HOW TO ENTER:** Beginning on September 15, at 9AM CT through October 15, 2025, at 10AM CT. You must fill in all required contact information on the form. You may enter only once. Use of any robotic, automatic, programmed, or similar entry method or entering more than the number of times permitted will void all entries and result in disqualification at the sole discretion of the Sponsor. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent these Official Rules. Entries that are not complete or do not adhere to the Official Rules or specifications may be disqualified at the sole discretion of the Sponsor. Sponsor reserves the right, at its sole discretion and for any reason, to cancel, terminate, modify or suspend the Promotion.

Each winner is subject to verification, including verification of residence and age of furnace. Notice to winner will be sent by email/phone and must sign and return any required Affidavit of Eligibility and Release within 10 days of the date notice is sent or such other date set by Sponsor. In order to
